

Pluto Journals publish 20 Diamond Open Access, radical, scholarly journals that are at the cutting edge of social science research and represent a global re-orientation of learning. We are an independent London based publisher that is owned by the not-for-profit Pluto Educational Trust. In 2021, we made our whole collection Open Access, hugely increasing usage across the world and democratising access to this valuable and significant research.

In 2024, user engagement continued to grow at 30% across the collection and more of our journals have been included in the scholarly indexes increasing their impact and profile. We are members of OASPA and most of our journals are now indexed on DOAJ.

Working with our partners the African Book Collective, we are pleased to have established the African Journals Initiative to Internationalise African Social Science and Humanities journals.



We have become a registered supplier to Lyrasis, the Greater Western Library Alliance and Jisc, which means that members can support our collection of 20 Diamond Open Access Social Science journals.

We rely on the support of libraries to publish this valuable open access collection and we are very grateful to all the libraries that have supported us to date.




GLOBAL COLLECTION



Our peer-reviewed journals cover key contemporary issues ranging from Islamic studies and post colonialism to political economy and labour rights, to intersectionality and disability studies. Over the last year, our journals have seen a significant increase in usage and impact, and more of our journals have been indexed on SCOPUS and included in CABS Academic Journal Guide.









International Journal of Disability Studies and Social Justice (IJDSJ) is an international and interdisciplinary journal in the field of Disability Studies, providing an outlet for scholars and academic-activists. It is concerned with critiquing injustice and finding ways to build inclusive environments, technologies and societies.

State Crime is administered by the International State Crime Initiative (ISCI). ISCI is a cross-disciplinary research centre working to further our understanding of state crime. State Crime Journal is the first peer-reviewed, international journal that seeks to disseminate leading research on the illicit practices of states.

Prometheus publishes critical papers, that express and justify opinions on innovation issues that challenge prevailing views. Prometheus aims to publish papers that are not so technical or specialised that they cannot be appreciated by a wide readership that includes academics, practitioners and policymakers.

Work Organisation, Labour and Globalisation aims to create a single, authoritative source of information on the new international division of labour, combining theoretical analysis with the results of empirical research in a way that is accessible both to the research community and to policy makers.








USAGE DATA

With their support, we have seen our user engagement in 2024 grow to **2,329,100** which is a **31%** increase on 2023.



Pluto Journals is an international, Diamond Open Access, scholarly publisher in the social sciences, it is owned by the not-for-profit Pluto Educational Trust. As such, it plays a unique and valuable role serving the establishment of new fields of critical scholarship.

We have a monthly Pluto Journals newsletter, highlighting all recently-published articles and which we promote on LinkedIn and BlueSky.

We also work actively with our journals to increase their discoverability and grow their usage offering support to improve the use of metadata.

The majority of our journals are now included in the **Directory of Open Access Journals** (DOAJ), the quality standard in Open Access journal publishing.

More of our journal are now indexed on **SCOPUS** and are included in the **CABS Academic Journal Guide.**





AFRICAN JOURNALS INITIATIVE



The <u>African Journals Initiative</u> has been established by <u>Pluto Journals</u> and the <u>African Books Collective</u>, working with a growing community of no-fee, diamond open access, social science and humanities journals based in African universities, and supported by <u>ScienceOpen</u> and <u>JSTOR</u>.


It is a three-year pilot programme to:

- Enhance the profile and discoverability of African journals
- Increase journal usage and submissions
- Mobilise financial support from academic libraries and consortia

An <u>Advisory Board</u> of African Academics with considerable experience of continent-wide programmes has been convened to support the initiative. The initiative will work with six established African social science and humanities journals annually.














LIBRARY SUPPORTERS

We are an authorised supplier to **Jisc**, the consortia organisation for UK Academic libraries, which means that UK institutions can support our collection of 20 Diamond Open Access Social Science Journals or just our **Islamic Journals Collection** which includes **Arab Studies Quarterly, Islamophobia Studies Journal, ReOrient, Bethlehem University,** and **Journal of Indentureship and its Legacies**.

- All of our journals have been Open Access since 2021.
- Authors are not charged an Author Processing Charge (APC).
- We are owned by the not-for-profit <u>Pluto Educational Trust</u>.
- Last year, our articles had 2,329,100 user engagements which is a 31% increase on 2023.
- We published more than 300 articles, covering a significant range of disciplines and have included hot topics like migration, SDG's, climate change, race and identity, and decolonisation.
